#### APRIL 2024 | WRITING COMPETITIONS

#### **EVERYTOWN LAW STUDENT WRITING COMPETITION**

This competition asks students to consider how to advance gun violence prevention and safety through litigation in the civil and criminal justice systems. All submissions must be received by **May 31, 2024**. Everytown may award up to three prizes: 1st prize of \$2,500 and 2 runners-up prizes of \$1,000.

#### ABA SECTION OF ENVIRONMENT, ENERGY, AND RESOURCES WRITING COMPETITION

The goal of the competition is to encourage law students to become involved in the Section. It is also intended to raise awareness of and foster dialogue regarding legal issues related to environmental, energy, and natural resources law and encourage scholarship in these fields. Application deadline is **May 31, 2024**. Award is \$1,000. There are five writing topics from which to choose from: Air, Water, and Food, Biodiversity, Energy Law, Indigenous Law, and Recycling.

#### ADAM A. MILANI DISABILITY LAW WRITING COMPETITION

The purposes of the competition are to promote greater interest in and understanding of the field of disability law and to encourage excellent legal writing skills in law students. First prize will range between \$300 and \$1,000, depending on whether multiple awards are given. Deadline for submission is **June 14, 2024**.

#### WILLIAM W. GREENHALGH STUDENT WRITING COMPETITION

This competition is sponsored by the Criminal Justice Section of the American Bar Association. The goal of the competition is to encourage law students to become involved in the Section. It is also intended to attract students to the Criminal Justice practice field, and to encourage scholarship in this field. Each entrant must follow the rules of the competition detailed <u>HERE</u>. The winner will receive a \$2,500 cash prize. Deadline for submission is **July 1, 2024**.

#### GEORGE JAY JOSEPH EDUCATION LAW WRITING AWARD

The purpose of this national competition is to generate increased interest in and recognition of education law among not only graduate students in education schools but also, in particular, to students in law schools. Nominations portal closes **July 31, 2024**.

### AMERICAN COLLEGE OF CONSUMER FINANCIAL SERVICES LAWYERS WRITING COMPETITION

This competition seeks to recognize written contributions to the field of U.S. consumer financial services law. Eligible entries must discuss some aspect of U.S. consumer financial services law. The awards include a cash payment (\$1,500 for student work). The deadline for entry is **November 1**, **2024**.

#### **GOVERNMENT LAW SECTION LAW STUDENT AWARD PROGRAM**

The Government Law Section of the Florida Bar has introduced an annual award program dedicated to fostering the next generation of local government law professionals. This program will provide a \$500 award and a commemorative plaque to one outstanding law student from each accredited law school in the State of Florida. Apply by **April 12, 2024**. #### MS. JD FELLOWSHIP APPLICATION

Each spring, Ms. JD selects a group of outstanding rising 3L students as Fellowship recipients. Fellows receive financial support to attend a Leadership Academy Intensive; attorney mentorship; attend monthly calls; and complete a fellowship project on their law school campus. Deadline to apply is **April 12, 2024**.

#### LGBT PUBLIC INTEREST SCHOLARSHIP PROGRAM

This scholarship is intended for law students and/or recent graduates studying for the Bar who are either LGBTQ+ or who will be working in the LGBTQ+ space doing public interest work. Apply by **April 19, 2024**. One or more scholarships of up to \$5,000 each awarded annually.

#### NACA SUMMER CONSUMER LAW FELLOWSHIP PROGRAM

This is a fellowship for both 1Ls and 2Ls with a demonstrated interest in consumer law and in serving low- and moderate-income consumers. It provides a stipend to students who spend the summer months working for a NACA member non-profit, legal aid, or private consumer law firm on consumer protection issues. Applications due **April 19, 2024**.

#### MIKE EDISON LAW STUDENT SCHOLARSHIP

Each year, the Women Trial Lawyers Caucus awards a \$5,000 scholarship to a female student entering their third year of law school (student can be enrolled in a 3-year day program or 4-year part time program) who has demonstrated a commitment to a career as a trial lawyer, along with dedication to upholding and defending the principles of the Constitution, and to the concept of a fair trial. Deadline to apply is **May 1, 2024**.

#### PAUL & DAISY SOROS FELLOWSHIPS FOR NEW AMERICANS

Each year, the Paul & Daisy Soros Fellowships for New Americans supports thirty New Americans — immigrants or the children of immigrants—who are pursuing graduate or professional school in the United States. Each Fellowship supports 1-2 years of graduate study in any field and in any advanced degree–granting program in the U.S. Each award is for up to a total of \$90,000. The National Association of Consumer Advocates (NACA) is offering a 2-year fellowship to recent law school graduates expected to sit for the July 2024 Florida Bar exam. During the 2-year program, the fellow will be an employee of Jacksonville Legal Aid. In the 2nd year, the fellow will be assigned to two different FL-based private consumer protection law firms. #### PUBLIC COUNSEL - CONSUMER RIGHTS & ECONOMIC JUSTICE FELLOW

The Fellow will assist low-income consumers across a range of debt collection and student loan matters, providing direct legal services, community education, and engaging in systemic advocacy. This position is based in Los Angeles, CA. Candidates must be registered for the July 2024 California State Bar Exam. Salary for Attorney with 0-1 years of experience is \$75,000. This position is open until filled.

#### LEGAL SERVICES ALABAMA - JOHN LEWIS LEGAL FELLOWSHIP

Fellows focus on using legal advocacy, education, and outreach to address community-identified issues in collaboration with client communities and Alabama's strong network of pro bono attorneys. Fellows advocate for clients, coalition build, conduct outreach and training, organize free legal clinics and lead legal service projects. Candidates will be sitting for a Bar Exam in July 2024 or February 2025 or are already licensed in any state. The position is open until filled. Salary is \$73,080 plus based on experience.

#### THE COUNCIL OF STATE GOVERNMENTS - LEGAL FELLOW - ECONOMIC MOBILITY

The fellow will assist in researching policies in each of the 50 states dealing with collateral consequences of conviction and mechanisms to mitigate their impact. The CSG Justice Center is based in NYC and offers flexibility in work arrangements, allowing for remote or a hybrid model. Apply by **May 4**, **2024**.

#### EQUITABLE ACCESS TO HOUSING FELLOWSHIP (2024-2025)

Allows 1 law school graduate each year to directly assist with the organization's impact litigation work, with a focus on litigation increasing housing access for low-income families, communities of color, and other groups facing housing discrimination. This is a 1-year fellowship, beginning Sept. 2024 with a salary of \$75,000. The Fellow is expected to sit for the July 2024 California bar exam. Applicants considered on a continuing basis, but priority given to those who submit applications by **April 15, 2024**.

#### **INNER CITY LAW CENTER - HOUSING JUSTICE FELLOWSHIPS**

Through their work, fellows keep low-income and vulnerable tenants housed, remove legal and financial barriers to housing, and fight to ensure tenants' rights to a safe and stable place to call home. This year, Public Counsel will consider fellowship proposals limited to those that fall within the scope of the following projects: Children's Rights, Community Development, and Opportunity Under Law (impact litigation).
