### GUARDIAN AD LITEM PROGRAM INTRODUCTION

As a volunteer, you are responsible for gathering facts surrounding a child's case, reviewing reports, finding out the child's wants and desires, visiting a child's home, school, or placement, and providing the court with an unbiased recommendation on what is required to serve the child's best interests. The volunteer assists in providing the judge with the information needed and what the child wants, so the judge can decide what is in the child's best interests. # RAICES LOOKING FOR REMOTE LEGAL INTAKE VOLUNTEERS (SPANISH SPEAKING)

RAICES, an immigrant justice non-profit located in Texas, defends the rights of immigrant, refugee, and asylum-seeking people and families, empowers communities, and advocates for liberty and justice. Immigrants in detention facilities in Texas have been contacting RAICES to get support for issues they are experiencing in detention. RAICES has been averaging between 50-60 calls for immigrants in detention in a matter of 3 hours and is in need of support to respond to the overwhelming needs of immigrants in detention. ### STETSON CLINICS AND EXTERNSHIPS - SPRING 2025

### ACLU-NBLSA SOUTHERN LEGAL INTERNSHIP PROGRAM - SUMMER 2025

Applications are now open for the Summer 2025 Legal Internship Program, a collaboration between the ACLU and the National Black Law Students Association (NBLSA). This summer internship will provide law students will experience in civil rights and social justice issues across the Southern U.S. Interns will be placed at ACLU affiliates in the 13 states of the Southern Collective, including Alabama, Arkansas, Florida, Georgia, Kentucky, Louisiana, Mississippi, North Carolina, South Carolina, Tennessee, Texas, Virginia, and West Virginia. Students are able to note the specific states where they are interested in working. Application deadline is **October 15**.

### FFLA CIVIL LEGAL AID SUMMER FELLOWSHIPS

Funding Florida Legal Aid will once again fund the Civil Legal Aid Summer Fellowship Program for the summer of 2025. The program offers approximately 10 law students the opportunity to gain valuable legal experience at a qualified Florida non-profit legal aid organization for a 10-week full-time paid summer fellowship. Student applications open October 4, 2024 and are due **November 1**. Offers will be released in early December. Stay tuned for additional details.

### ANIMAL LEGAL DEFENSE FUND LITIGATION PROGRAM - SUMMER 2025 CLERKSHIPS

The Animal Legal Defense Fund summer clerkship program gives law students who demonstrate an interest in animal law the opportunity to work with and be trained by top experts in the field. Clerks are integral members of a program team and work on projects that further the current work of the program and advance the mission and goals of the Animal Legal Defense Fund. Clerks work remotely, and deadline to apply is **October 28**.

### NATURAL RESOURCES DEFENSE COUNCIL SUMMER LEGAL INTERNSHIPS

NRDC is seeking to hire a cohort of Summer Legal Interns to work on cases and projects with attorneys on their Litigation Team and within core issue areas (Environmental Health, Equity & Justice, Climate & Energy, and Nature). Intern positions are available in our New York, D.C., Chicago, Santa Monica, and San Francisco offices. This is a paid internship and NRDC offers up to \$10,000 for the 10 week program. ### SEIU NORM GLEICHMAN LAW FELLOWSHIP

The Legal Department of the Service Employees International Union is seeking a 2025 law fellow. Fellows work with experienced union-side lawyers on a variety of cutting-edge issues related to the advancement of workers' interests. The Fellowship is based in Washington, DC. The application process is on a rolling basis and will close on **October 18**.

### EQUAL JUSTICE INITIATIVE LEGAL FELLOWSHIP

2-year fully funded fellowship for graduating law students beginning September 2025, based in Montgomery, AL. EJI is a nonprofit law office and human rights organization that provides legal assistance to condemned prisoners, children in the criminal justice system, people wrongly convicted or sentenced, and the poor and vulnerable facing imprisonment. Deadline to apply is **November 8**.

### **LEGAL AID DC - 2025 STAFF ATTORNEY CLASS**

Legal Aid DC is seeking to hire a class of entry-level attorneys to start working as direct services attorneys in September 2025. Those hired will receive an assignment in one of the following units before their start date: consumer law, domestic violence/family law, housing, public benefits, immigration, and reentry justice. Law students with graduation dates expected in the summer of 2025 are eligible to apply. Applications will open on January 6, 2025, and must be submitted by **January 31**.

### NATURAL RESOURCES DEFENSE COUNCIL LITIGATION FELLOWSHIP

NRDC is seeking a Litigation Fellow to work with the Litigation team in one of their U.S. offices: Chicago; New York; San Francisco; Santa Monica; or Washington, D.C. The term for this fellowship is Fall 2025 through Fall 2027, with the possibility of extension through Fall 2028. The fellowship is open to current law students who will graduate this academic year. Applicants must be available to start no later than Fall 2025. Applications will be considered on a rolling basis with preference for applicants who apply by **October 15**.

### 2025-2027 ARYEH NEIR LEGAL FELLOWSHIP

The ACLU and Human Rights Watch invite applications for the Aryeh Neier Fellowship. The fellow will work with both organizations on joint initiatives to strengthen respect for human rights in the United States. The fellow will most likely be placed in the NYC offices of Human Rights Watch and the ACLU, spending a year at each; however, the fellow should be open to placement in the organizations' offices in other locations in the US. Apply by 11:59 PM ET on **October 13**.

### VETERANS LAW FELLOWSHIP - CORNELL LAW SCHOOL

The fellow will work exclusively on cases for Veterans, with a primary focus on helping those at risk of becoming unhoused for a period of 1-year. Applicants must plan to sit for the July 2025 New York State bar exam. To ensure maximum consideration, submit all application materials by **October 15**. Applications will be reviewed on a rolling basis, with priority given to early applicants.

Join the Public Service Loan Forgiveness (PSLF) Coalition on **October 30** at 1:00 p.m. for a monthly webinar, where they will share information you need to know about earning PSLF. PSLF is the only educational debt program specifically targeted at public service professionals. After working in a full-time public service position for 10 years while making ongoing monthly student loan repayments, borrowers are eligible to earn forgiveness on their remaining federal loan balance thanks to PSLF.
