U.S. DEPT OF VETERANS AFFAIRS OFFICE OF GENERAL COUNSEL - PRO BONO INTERNSHIP

VA OGC specializes in federal administrative law, representing the Dept. in employment law cases and handles matters in a wide range of administrative law topics, including health care law and benefits issues. Placement is in St. Petersburg or Tampa, depending on availability/preferences. Students have the opportunity to work in person and/or virtually and should plan to work at least 1-2 days per week (Tues., Wed., or Thurs. preferred, but flexible). Please apply only if you can dedicate a minimum of 8 weeks. SPRING/SUMMER PUBLIC INTEREST OPPORTUNITIES

STETSON CLINICS AND EXTERNSHIPS - SPRING 2025

The applications for Spring 2025 Clinics and Externships are now OPEN and will close **November 11**. These experiences allow students to observe and participate in the application of substantive law, and find solutions to problems that confront attorneys on a daily basis. Apply [HERE](#). Students earn 30 legal hours of pro bono upon successful completion of a clinic program.

FFLA CIVIL LEGAL AID SUMMER FELLOWSHIPS

The program offers approximately 10 law students the opportunity to gain valuable legal experience at a qualified Florida non-profit legal aid organization for a 10-week full-time paid summer fellowship. Student applications are due **November 8**. Offers will be released in early December.

NAACP SUMMER 2025 LAW STUDENT LEGAL INTERNSHIP

The NAACP Legal Defense and Educational Fund (LDF) is accepting applications for 2025 summer litigation internships for the New York, Washington D.C., and Atlanta offices. Interns will be in-person in their assigned office 2 days a week and work primarily on litigation-related projects. Interns will be exposed to a variety of activities within the broader national civil rights coalition, including joining brown bag luncheons featuring prominent civil rights and public interest attorneys. Positions filled on a rolling basis so applicants are encouraged to apply as soon as possible.

PEGGY BROWNING FUND SUMMER FELLOWSHIPS

Applications for PBF Fellowships will open November 8. The program provides stipends to law students who dedicate their summer to advancing workers' rights by working for labor unions, worker centers, labor-related not-for-profit organizations, union-side law firms and other nonprofit organizations. It is a 10-week summer fellowship and is available to 1L, 2L, and 3E law students.

HAYWOOD BURNS MEMORIAL SUMMER FELLOWSHIPS

The Haywood Burns Fellowships are designed to encourage students to work in the National Lawyers Guild's tradition of people's lawyering. Fellowships may be completed with NLG aligned organizations or law firms whose mission is in line with the Guild's commitment to prioritizing people and ecosystems over property interests. The deadline to apply is **January 6**.

PILI SUMMER INTERNSHIP PROGRAM

PILI's Law Student Internship Program connects law students from across the country with public interest law agencies in Illinois and pays them for their work. Summer interns will receive \$6,500 for working 400 hours. The application system will open at 10am CST on November 1st for 2Ls and November 15 for 1Ls.

SUMMER EQUAL JUSTICE AMERICA LEGAL SERVICES FELLOWSHIPS

EJA offers summer fellowship grants up to \$5,000. To apply, students must secure a full-time placement for the summer working a minimum of 10 weeks at a civil legal services organization. To be eligible for an EJA fellowship, students from Stetson Law must choose a placement with a legal aid program within Florida. Deadline to apply is **March 24**.

JANET D. STEIGER FELLOWSHIP PROJECT - SUMMER

Provides law students with the opportunity to work in the consumer protection departments of state and territorial Offices of Attorneys General and other consumer protection agencies, as well as the National Association of Attorneys General and the Attorney General's Office of the District of Columbia. Selected students receive a \$6,000 stipend. Deadline to apply is **November 29**.

2025 POST-GRADUATE OPPORTUNITIES

NACA CONSUMER LAW 2-YEAR FELLOWSHIP

The National Association of Consumer Advocates (NACA) is offering 2-year consumer law fellowships to upcoming law school graduates who are expected to sit for the July 2025 Bar exam. Review a list of approved host organizations and projects [here](#). Deadline to apply is **January 1**.

KIVU IMMIGRATION LAW FELLOWSHIP

Kivu Immigration Law PLLC is a Minnesota-based firm that recently launched a two-year, paid fellowship program that seeks upcoming and recent law graduates committed to providing legal services for refugees and immigrants. Fellows receive training and mentorship in order to provide holistic legal representation on immigration matters and engage in on-the-ground community advocacy with schools, businesses, and other local community organizations. Applicants may be 3Ls, graduating law school by the spring of 2025, and must have already passed a state bar exam, or plan to take a state bar exam in July 2025. Deadline to apply is **November 10**.

EQUAL JUSTICE INITIATIVE LEGAL FELLOWSHIP

2-year fully funded fellowship for graduating law students beginning September 2025, based in Montgomery, AL. EJI is a nonprofit law office and human rights organization that provides legal assistance to condemned prisoners, children in the criminal justice system, people wrongly convicted or sentenced, and the poor and vulnerable facing imprisonment. Deadline to apply is **November 8**.

FEDERAL COMMUNICATIONS COMMISSION ATTORNEY HONORS PROGRAM

The Attorney Honors Program is the FCC's primary vehicle for hiring entry-level attorneys. AHP participants serve in a 2-year program designed to introduce them to the field of communications law and policy. The FCC encourages law students in their final year of study, recent law school graduates, and current judicial clerks with superior academic credentials and an interest in public service and communications law to apply. Deadline to apply is **November 21**. Position based in Washington, DC.

2025-27 VOTING RIGHTS PROJECT LEGAL FELLOWSHIP

Fair Elections Center is seeking current law school students, recent graduates, or judicial law clerks with a background or strong interest in civil rights, voting rights, or election reform to work on cutting-edge voting rights litigation for a fully funded legal fellowship. The applicant must hold a J.D. by the summer of 2025 and take the bar in any state. The position is remote, but some travel may be required. Position open until filled so early applications are encouraged.

DEPARTMENT OF ENERGY - LAW CLERK/ATTORNEY

The Honors Attorney Program will provide mentoring and training in a wide variety of legal practice including environmental law, legislation and regulation, litigation and enforcement, international law, nuclear energy, electricity and fossil energy, clean energy and energy efficiency, procurement, intellectual property, fiscal and privacy law, government ethics, and federal employment and labor law. Current law school students in their final year of law school eligible to apply. Deadline to apply is **November 18**.

Join the Public Service Loan Forgiveness (PSLF) Coalition on **December 11** at 1:00 p.m. for a monthly webinar, where they will share information you need to know about earning PSLF. PSLF is the only educational debt program specifically targeted at public service professionals. After working in a full-time public service position for 10 years while making ongoing monthly student loan repayments, borrowers are eligible to earn forgiveness on their remaining federal loan balance thanks to PSLF.
