SUMMER 2025 OPPORTUNITIES

EQUAL JUSTICE WORKS - RURAL SUMMER LEGAL CORPS STUDENT FELLOWSHIP

The Rural Summer Legal Corps connects public interest law students with LSC-funded civil legal aid organizations nationwide to address critical legal issues facing rural communities. This year, 50 Fellows will be hosted by organizations across the U.S. Each Fellow will spend 8-10 weeks working on a uniquely designed community project at their host and earn \$7,000 for working 300 hours. EQUAL JUSTICE WORKS DISASTER RESILIENCE PROGRAM STUDENT FELLOWSHIP

The [Disaster Resilience Program](#) places law students at legal services organizations where they gain exposure to strategic policy and advocacy, legal disaster preparedness, and recovery work. Student Fellows spend eight to ten weeks working alongside Equal Justice Works post-graduate Fellows, while developing valuable skills and gaining hands-on experience in disaster law. Students earn \$7,000 for working 300 hours during the summer of 2025.

ABA JOHN J. CURTIN, JR. JUSTICE FUND 2025 SUMMER LEGAL INTERNSHIP PROGRAM

The Curtin Justice Fund Legal Internship Program is seeking motivated law student interns to apply for stipends available for the Summer Program. These students should have a position offered, contingent on funding, from a qualified organization. The Program will pay a \$3,500 stipend to three law students who spend the summer months working for a bar association or legal services program designed to prevent homelessness or assist homeless or indigent clients or their advocates. Applications are accepted on a rolling basis through **March 28**.

EQUAL JUSTICE AMERICA SUMMER LEGAL SERVICES FELLOWSHIPS

EJA offers summer fellowship grants up to \$5,000. To apply, students must secure a full-time placement for the summer working a minimum of 10 weeks at a civil legal services organization. To be eligible for an EJA fellowship, students from Stetson Law must choose a placement with a legal aid program within Florida. Deadline to apply is **March 24**.

FLORIDA ATTORNEY GENERAL'S SUMMER INTERNSHIP PROGRAM

Interested students are directed to complete and submit the appropriate application packet prior to the **February 28** for Summer 2025 internships. Applications are accepted on a rolling basis.

FEDERAL DEFENDER, MIDDLE DISTRICT OF FLORIDA - SUMMER INTERNSHIP PROGRAM

The goal of the Office of the Federal Defender is to ensure the right to provide effective assistance of counsel to those accused of federal crimes as guaranteed by the Sixth Amendment. The Middle District of Florida has a limited number of placements in each division: Tampa, Orlando, Jacksonville, Fort Myers, and Ocala. For summer, the deadline to submit your application is **February 28**.

SUMMER 2025 OPPORTUNITIES

U.S. DEPARTMENT OF VETERANS AFFAIRS OGC, SOUTHEAST DISTRICT - SUMMER INTERNS

Selected students research legal issues, draft memoranda or law and pleadings, and assist attorneys during trials, arbitrations, mediations, depositions, and conferences with administrative law judges. Placement is in one of OGC's Core Offices in St. Petersburg or Tampa, depending on availability and preferences of selectees. Students should plan to work at least one day per week in the office (Wednesday is preferable, but flexible). Please apply only if you are able to dedicate a minimum of 8 weeks. LAWYERS' COMMITTEE FOR CIVIL RIGHTS UNDER LAW - SUMMER LEGAL INTERN

The Lawyers' Committee for Civil Rights Under Law is offering legal internships to support their work to achieve racial justice. Interns contribute to projects that make impactful change and provide the intern with professional and personal development. This position will be based in Washington, DC and offers a stipend of \$7,500. Deadline to apply is **February 28**.

NATIONAL ASSOCIATION OF CRIMINAL DEFENSE LAWYERS DIVERSITY SUMMER FELLOWSHIP

Provides opportunities for law students from historically underrepresented backgrounds to work with exceptional and experienced criminal defense attorneys. Earn up to \$4,500 for up to 8 weeks of employment. Students may apply to receive funding for an internship they have already secured or can choose from the Fellowship's broad array of potential employers, including solo practitioners, firms, and state/federal public defense agencies, located throughout the U.S. Apply by **February 18**.

CENTER FOR HIV LAW & POLICY - LEGAL INTERNSHIP SUMMER 2025 REMOTE

CHLP is an abolitionist legal and policy organization that envisions and works for a world where HIV and other stigmatized health conditions are no longer criminalized but met with compassion and the resources to thrive. Summer intern assignments will likely include legal research in support of advocacy for individuals in civil confinement, research to assist attorneys advising state coalitions, analyses for the HIV Policy Resource Bank, and more. Compensation is \$20/hour based on a 35-hour week. Applications accepted on a rolling basis so early applications are encouraged.

ANIMAL LEGAL DEFENSE FUND - LEGISLATIVE AFFAIRS PROGRAM **SUMMER 2025 CLERKSHIPS (REMOTE)**

ALDF's summer clerkship program gives law students who demonstrate an interest in animal law the opportunity to work with and be trained by top experts in the field. Clerks will gain experience with and knowledge of animal protection issues, campaigns, and advocacy, while improving skills in research, writing, legislative analysis, coalition-building, and lobbying strategies. Compensation is \$20/hour. Deadline to apply is **March 10**.

BERGSTROM CHILD WELFARE FELLOWSHIP PROGRAM

Through the fellowship, students gain experience and insight into the field and provide much-needed services to various child welfare offices specializing in representing children, parents, and social service agencies. After attending a retreat in May, fellows spend at least 10 weeks at a child welfare law internship. Travel costs to the retreat and to fellows' summer internships or home after the event will be covered by the program. Deadline to apply is **March 31**.

POST-GRADUATE OPPORTUNITIES

LEGAL AID DC - 2025 STAFF ATTORNEY CLASS

Legal Aid DC is seeking to hire a class of entry-level attorneys to start working as direct services attorneys in September 2025. Those hired will receive an assignment in one of the following units before their start date: consumer law, domestic violence/family law, housing, public benefits, immigration, and reentry justice. Law students with graduation dates expected in the summer of 2025, taking the July DC Bar Exam, encouraged to apply. Applications must be submitted by **January 31**.

LEGAL AID CHICAGO - 2025 STAFF ATTORNEY CLASS

Legal Aid Chicago is seeking to hire full-time staff attorneys to begin in fall 2025. Applicants must be willing to work in any of the following of Legal Aid Chicago's practice groups: Children & Families, Consumer, Housing, Immigrant & Workers' Rights, Pro Bono & Community Partnerships, and Public Benefits. OFFICE OF CRIMINAL CONFLICT & CIVIL REGIONAL COUNSEL, 5TH REGION - ATTORNEYS

The Office of Criminal Conflict and Civil Regional Counsel, 5th Region, is a State of Florida Agency that represents indigent individuals in over 20 different areas of law, both criminal, where the Public Defender has a conflict or if there are co-defendants, and civil. criminal attorneys handle full dockets of felony, misdemeanor, and juvenile delinquency cases, including death penalty cases.
