# STETSON LAW PUBLIC INTEREST CAREER FAIR

Are you passionate about using your law degree to make a positive impact? #### SUMMER 2025 OPPORTUNITIES

#### JWLA SUMMER INTERNSHIP AT JACKSONVILLE AREA LEGAL AID

The Jacksonville Women Lawyers Association's (JWLA) mission is to actively promote gender equality in the legal profession. This internship offers critical legal experience for a law student, while also providing needed legal services in the Jacksonville community. The internship is a paid position at Jacksonville Area Legal Aid. Preference will be given to students who are FAWL members. The position will be 16–20 hours/week for 10–12 weeks at \$18/hour. Applications due by **March 19**.

# SOUTHERN LEGAL COUNSEL SUMMER 2025 LAW CLERK OPPORTUNITIES

Law Students conduct legal research and factual investigation; prepare legal memoranda; draft and review public records requests and responses; assist in all aspects of discovery such as document analysis, organization and indexing depositions; and assist in preparation of legal documents and pleadings. Since most of the work concerns federal court litigation, there is substantial legal research and writing involved. Excellent research, oral and written communication skills required with demonstrated interest in law, civil rights, and/or public policy. Second or third year students are preferred. Deadline to apply is **March 1**.

#### EQUAL JUSTICE WORKS DISASTER RESILIENCE PROGRAM STUDENT FELLOWSHIP

The <u>Disaster Resilience Program</u> places law students at legal services organizations where they gain exposure to strategic policy and advocacy, legal disaster preparedness, and recovery work. Student Fellows spend 8-10 weeks working alongside EJW post-grad Fellows, while developing valuable skills and gaining hands-on experience in disaster law. Applications due **February 25**. Students earn \$7,000 for working 300 hours during the summer. <u>View the legal aid organizations hosting Fellows this summer, and the corresponding project descriptions</u>. #### BERGSTROM CHILD WELFARE FELLOWSHIP PROGRAM

Students gain experience and insight into the field and provide much-needed services to various child welfare offices specializing in representing children, parents, and social service agencies. After attending a retreat in May, fellows spend at least 10 weeks at a child welfare law internship. Deadline to apply is **March 31**.

#### ABA JOHN J. CURTIN, JR. JUSTICE FUND 2025 SUMMER LEGAL INTERNSHIP PROGRAM

The Curtin Justice Fund is seeking motivated law student interns to apply for summer stipends. Applicants should have a position offered, contingent on funding, from a qualified organization. The Program will pay a \$3,500 stipend to 3 law students who spend the summer working for a bar association or legal services program designed to prevent homelessness or assist homeless/indigent clients or their advocates. Applications accepted on a rolling basis through **March 28**.

#### **EQUAL JUSTICE AMERICA SUMMER LEGAL SERVICES FELLOWSHIPS**

EJA offers summer fellowship grants up to \$5,000. To apply, students must secure a full-time placement for the summer working a minimum of 10 weeks at a civil legal services organization. To be eligible for an EJA fellowship, students from Stetson Law must choose a placement with a legal aid program within Florida. Deadline to apply is **March 24**.

# **KOZYAK SUMMER FELLOWSHIP FUND**

This fellowship awards \$5,000 in summer legal fellowships to allow Florida-based law students to have some financial support while gaining valuable experience during unpaid public service, government, non-profit, or judicial summer internships. #### OFFICE OF CRIMINAL CONFLICT & CIVIL REGIONAL COUNSEL, 5TH REGION - ATTORNEYS
