EQUAL JUSTICE WORKS Applications for class of 2026 Are open

Through the <u>Design-Your-Own Fellowship</u> program, Equal Justice Works seeks to create opportunities for new lawyers to transform their passion for equal justice into a lifelong commitment of public service. During the 2year fellowship, nonprofit organizations working on legal issues ("Host Organizations") host Fellows, providing them salary and benefits comparable to similarly situated staff. Fellow applicants forge their own path by working with a Host Organization to design a project that addresses an issue and community they care passionately about serving.

Applications are due September 18, 2025. If you haven't secured a host organization yet, there's still time to do so!

STUDENT OPPORTUNITIES

ADVOCATES FOR TRANS EQUALITY - FALL 2025 LEGAL INTERNSHIP

A4TE is a national organization committed to advancing justice and equity for transgender and nonbinary people through impact litigation, direct legal services, advocacy, and public education. Fall legal interns will primarily assist the impact litigation and Trans Health Project teams with legal research & writing, direct representation, policy advocacy, alternative dispute resolution, and client intake. The fall internship is a 12-week, part-time position with availability for at least 12 hours/week. Compensation is \$17/hour and the position is remote. Applications will be accepted until positions are filled.

GULFCOAST LEGAL SERVICES - FALL 2025 LAW CLERK POSITIONS

Gulfcoast Legal Services is currently seeking applicants for Fall 2025 part-time, paid law clerk positions in one of the following units: Family Law, Financial Stability, Housing, Special Projects, and Pro Bono. The positions are based in one of the following offices: St. Petersburg, Bradenton, Sarasota, Wimauma, and may involve travel as necessary to best serve clients. Compensation starts at \$22/hour. US ATTORNEY'S OFFICE, MIDDLE DISTRICT OF FL - LAW STUDENT VOLUNTEER (SPRING 2026)

Assignments for law student volunteers include drafting responsive motions, dispositive motions, memoranda of law, and appellate briefs. In addition, interns may attend dispositions, meetings with Agents, and accompany attorneys to observe court proceedings. Available practice areas include Appellate Litigation, Civil Litigation, and Criminal Litigation. Those applying to the Tampa office should indicate their preferred practice area. Other branch office applicants will be placed in the Criminal Division. Deadline to apply for Spring 2026 is 10/3/25. While positions are unpaid, hours are eligible for legal pro bono credit.

EARTHJUSTICE - SUMMER 2026 LAW CLERK PROGRAM

Earthjustice is accepting applications for Summer 2026 Law Clerkships from July through Labor Day 2025. Summer law clerks will have the opportunity to work with several attorneys on case development and litigation strategy. Students may draft pleadings and briefs, do legal research, develop strategy and legal theories, gather evidence, and attend client meetings and court proceedings. Clerks will receive a one-time stipend at the start of the clerkship in the amount of \$1,320/week, minus the total amount received from any other sources and applicable taxes. The clerkship is designed to be 10 weeks long at full-time hours. Positions available across various offices, including the Florida Regional Office.

Fellows receive funding, support, and training to launch innovative legal initiatives that expand access to justice in underserved communities. The deadline to <u>apply</u> is 9/18/25. Applicants must secure a host organization and develop a project in tandem with their host organization before applying. SKADDEN FOUNDATION FELLOWSHIPS

The Foundation awards 2-year fellowships to law school graduates, outgoing judicial law clerks, and LLM candidates who want to work in the public interest. Candidates partner with an eligible nonpartisan 501(c)(3) organization to develop a project that addresses the unmet civil legal needs of people living in poverty in the US. The deadline to apply is 9/19/25. Applicants must secure a host organization and develop a project in tandem with their host organization before applying. 2026 POSTGRADUATE OPPORTUNITIES

AMERICANS UNITED - CONSTITUTIONAL LITIGATION FELLOWSHIP (2026-2028)

Americans United is seeking a 2-year Fellow who is committed to civil rights, impact litigation, and upholding core First Amendment protections. Work would include defending rights of women, LGBTQ+ people, and racial and religious minorities against religion-based discrimination and oppression. Salary is \$81,600-\$102,000 annually, depending on experience and location. Fellows can work remotely from: California, Indiana, Louisiana, Massachusetts, Maryland, Maine, Montana, NY, Pennsylvania, Tennessee, Texas, Virginia, Washington, Wyoming, and Washington, DC. <u>Apply</u> by 9/12/25.

IMMIGRANT JUSTICE CORPS - JUSTICE FELLOWSHIP (2026-2028)

2-year Justice Fellowships are awarded to recent law graduates from around the country. IJC matches Fellow candidates with partnering host organizations based on the applicant's experience and preference, gaps in services within the country, and host organization needs. Applicants must graduate law school by the spring of 2026. <u>Apply</u> by 10/19/25 at 11:59 ET.

FRIED FRANK - CIVIL RIGHTS FELLOWSHIP PROGRAM

Accepts applications from 3L students graduating in 2026. This year, they will select one Fried Frank Fellow in partnership with the NAACP Legal Defense Fund to begin at Fried Frank in 2026. The first 2 years of the fellowship will take place at Fried Frank's NYC office. Following the Fried Frank placement, LDF Fellows work at the New York City office of LDF. <u>Apply</u> by 10/14/25 at 11:59 EST.

EQUAL JUSTICE INITIATIVE - LEGAL FELLOWSHIP (2026-2028)

As part of the fellowship, EJI is engaging in an initiative on race and poverty that seeks meaningful solutions to long-standing problems. In addition, they are challenging excessive and abusive punishments imposed on children in the US, working on large reform projects relating to racial injustice and economic inequality, and maintain a large docket of death penalty cases, wrongful conviction cases, and civil rights cases. EJI will accept applications for the fellowship from 8/1-11/6/25. This position is based in Montgomery, AL.

MACDONALD HOAGUE & BAYLESS CIVIL RIGHTS LITIGATION FELLOWSHIP (2026-2028)

This Fellowship will begin in September 2026 and will provide an opportunity to participate fully in all aspects of MHB's Seattle-based civil rights practice, representing victims of police and prosecutorial misconduct; workplace injustice; discrimination based on protected identities; inhumane prison conditions; housing discrimination; and others harmed by government or corporate wrongdoing. Applicants must plan to take the Washington State bar exam by Fall 2026. Pay is \$81,000 for the 1st year and \$87,000 for the 2nd year. <u>Apply</u> by 9/10/25 at 11:59 PST.

GEORGIA ATTORNEY GENERAL'S HONORS FELLOWSHIP PROGRAM

The Honors Fellowship is a 2-year program for entry-level attorneys who are committed to public service. Honors Fellow candidates are current law students seeking post-graduation employment and recent law graduates employed in judicial clerkships or legal fellowships. Fellows will gain experience in legal research; discovery; motions practice; brief writing; and client interactions. Fellows who work in litigation sections should expect deposition and courtroom experience. <u>Apply</u> by 9/20/25.
