#### PRO BONO OPPORTUNITIES

#### **TEEN COURT**

Looking for a unique way to earn legal pro bono hours? Join St. Pete Teen Court, a diversion program that gives juveniles a second chance when facing their first encounter with the criminal justice system.

- Sanctions are decided by a jury of the youth's peers, and participants are required to take responsibility for their actions and accept the consequences set by the peer court, students from various high schools in the community.
- Students Law students serve as judge during these proceedings.
- Sessions are held on Tuesday evenings from 4:45-7:00 p.m. in St. Petersburg.

#### STETSON IMMIGRATION LAW FELLOWSHIP (FALL 2025)

Stetson Law and Americans for Immigrant Justice (AI Justice) invite dedicated law students to join the Family Defense and Detention Programs. These programs support Florida's immigrant communities – especially long-term residents, mixed-status families, and detained individuals, through legal services and education. Fellows must commit to give (5) hours per week, with a maximum of twenty (20) hours per month, and will receive pro bono hours towards the graduation requirement. #### SEPTEMBER FAMILY FORMS CLINIC

Bay Area Legal Services is seeking law student volunteer to participate in the Family Forms Clinic at the George Edgecomb Courthouse in downtown Tampa. As a student volunteer, you will help pro se family law litigants complete family law forms. No experience or expertise is needed. All students are eligible to sign-up. #### **VOTER ACTION PINELLAS (FALL 2025)**

Voter Action Pinellas (<a href="https://www.voteractionpinellas.org/">https://www.voteractionpinellas.org/</a>), a nonprofit voter advocacy group, has pro bono opportunities available for students who can commit to at least fifteen hours during the fall. They can structure an unpaid internship with a commitment of at least forty hours, and can provide sixty or more hours for students interested in fulfilling their entire pro bono commitment this fall. The internship can include legal and/or nonlegal work, and is available for students at any stage of their studies. They'll provide training as necessary. #### SOUTHERN POVERTY LAW CENTER - SUMMER 2026 LEGAL INTERNSHIP

SPLC is currently accepting applications for their Summer 2026 Legal Internship. This is a full-time paid internship at \$17.50/hour. SPLC offers both remote and hybrid opportunities, with offices in Montgomery, AL; Atlanta, GA; Jackson, MS; New Orleans, LA; Washington, DC; and Florida areas. Applications are due by **Sept. 30**. #### FFLA 2026 CIVIL LEGAL AID SUMMER FELLOWSHIP PROGRAM

The Civil Legal Aid Summer Fellowship Program offers law students the opportunity to gain valuable legal service experience at a Florida non-profit legal service organization for a 10-week full-time paid summer fellowship. This year, FFLA will offer up to 30 law students fellowships. Stipends for students are \$9,000. The 2026 application window will be open from **Oct. 1 - Nov. 7**. Stay tuned for additional details.

#### EARTHJUSTICE - 2026 LAW CLERKSHIPS

Earthjustice will accept Summer 2026 Law Clerkship applications **through Labor Day**. Earthjustice will provide a one-time stipend at the start of the clerkship in the amount of \$1,320/week.
