#### PRO BONO OPPORTUNITIES

#### COMMUNITY ASSOCIATES PROGRAM

If you are interested in creating, working, or learning about nonprofit organizations and the intersection of philanthropy and the law this is a pro bono opportunity you do not want to miss! The Alliance for Advocacy and Philanthropy (The Alliance) is seeking student pro-bono interns to work virtually on a variety of projects with nonprofit organizations in the Tampa Bay area. The Alliance is a partnership between the Community Foundation of Tampa Bay and Stetson University College of Law. It is a partnership designed to engage students in the philanthropic community and to strengthen the effectiveness of nonprofit efforts to address the needs of communities in the Tampa Bay area.

Students who volunteer for these pro bono opportunities are required to commit to working at least three hours per week for a minimum of 6 weeks starting September 12. The preference is for longer multiweek engagements, but short-term one-time opportunities may also be available. Many of the assignments will be virtual.

Stetson Law and Al Justice invite dedicated law students to join the Family Defense and Detention Programs. These programs support Florida's immigrant communities—especially long-term residents, mixed-status families, and detained individuals, through direct legal services, and education.

### Fellow Responsibilities:

- Conduct intakes, legal research, and assist in drafting filings.
- Support immigration relief applications (e.g., asylum, TPS, family petitions).
- Assist in drafting personal declarations and court documents.
- Participate in legal clinics, immigration appointments, Know Your Rights presentations, and rapid response outreach.
- Receive training from Al Justice attorneys and Stetson faculty.

#### SPRING 2026 OPPORTUNITIES (2L/3L)

#### FLORIDA SUPREME COURT FELLOWS PROGRAM - SPRING 2026

This program provides law students a unique opportunity to learn about the operation of Florida's highest court and gain experience as future lawyers and leaders in their communities. Fellows will work as an intern to an individual justice, a central staff intern working for all the justices, an intern working with the clerk of court and the administrative justice, or as an intern for the Office of the State Courts Administrator General Counsel. Applicants must be classified as a 3L, or second semester, 2L during their time in the program and be in the top 25 percent of their class. Fellows receive \$15.75 per hour, will work up to 20 hours/week, and must reside in the Tallahassee area during the program. Applications are due **Sept. 30**.

#### FLORIDA ATTORNEY GENERAL'S INTERNSHIP PROGRAM - SPRING INTERNSHIP

The Attorney General serves as the attorney for the State of Florida and as a member of the Florida cabinet. Interning for the Office of the Attorney General affords law students an opportunity to gain practical experience in a legal field and offers students a chance to perform meaningful work toward the completion of their degree. Students must be able to intern a minimum of 20 hours per week. Interested students are directed to complete and submit an application packet prior to **Oct**. **31**; however, students are encouraged to apply early as applications are accepted on a rolling basis. Law students who are not receiving academic credit are eligible to receive legal pro bono credit towards the graduation requirement.

#### FEDERAL DEFENDER, MIDDLE DISTRICT OF FLORIDA - SPRING INTERNSHIP

Student interns may conduct legal research, draft motions, memoranda, and assist with appellate briefs and/or habeas corpus petitions. The student may also assist with trial prep and investigation/mitigation, to include interviewing clients and witnesses, visiting clients in local jails facilities, and helping the attorneys plan case strategies. This opportunity is a non-paid position and eligible for legal pro bono credit, provided the student is not receiving academic credit for their work. The deadline to submit an application is **Nov. 30**. There are a limited number of placements available in each division: Tampa, Orlando, Jacksonville, Fort Myers, and Ocala.

#### <u>USAO MIDDLE DISTRICT OF FLORIDA - LAW STUDENT VOLUNTEER, SPRING 2026</u>

The USAO's Middle District Office is located in Tampa, with branch offices in Orlando, Jacksonville, Fort Myers, and Ocala. Law student volunteer assignments include, drafting responsive motions, dispositive motions, memorandum of law, and appellate briefs. In addition, interns may attend dispositions, meetings with Agents and accompany attorneys to observe court proceedings. Practice areas include Appellate Litigation, Civil Litigation, and Criminal Litigation. The deadline to apply is **Oct. 3**. This opportunity is eligible for legal pro bono credit towards the graduation requirement.
