#### SPRING 2026 OPPORTUNITIES (2L/3L)

#### NATIONAL CENTER FOR YOUTH LAW - SPRING 2026 LITIGATION CLERKSHIPS

NCYL is a national nonprofit that puts children at the center of every fight for justice and seeks 2-4 law students to support its litigation team during the spring of 2026. Litigation clerks will support NCYL's active litigation to advance the rights of children and youth. These are remote, volunteer positions, eligible for legal pro bono credit. Applications will be reviewed until positions are filled or until Nov. 21. Priority will be given to applications received before **Nov. 7**.

#### CENTER FOR CONSTITUTIONAL RIGHTS - SPRING INTERN 2026 (REMOTE)

CCR seeks experienced second- or third-year law students or LLM students with a strong commitment to social justice to provide legal research and analysis as part of a semester-long paid internship or externship opportunity. The intern will spend 12-20 hours/week between January and May 2026 assisting attorneys on projects. If interns are unable to secure funding, they are eligible to receive pro-rated funding based on hours worked and degree pursued at a range of \$2,200 to \$7,500. Deadline to apply is **Nov. 28**.

#### FEDERAL DEFENDER, MIDDLE DISTRICT OF FLORIDA - SPRING INTERNSHIP

Student interns may conduct legal research, draft motions, memoranda, and assist with appellate briefs/habeas corpus petitions. #### SUMMER 2026 OPPORTUNITIES

#### FFLA 2026 CIVIL LEGAL AID SUMMER FELLOWSHIP PROGRAM

The Civil Legal Aid Summer Fellowship Program offers law students the opportunity to gain valuable legal service experience at a Florida non-profit legal service organization for a 10-week full-time paid summer fellowship. This year, FFLA will offer up to 30 law students fellowships. Stipends for students are \$9,000. Deadline to apply is **Nov. 7**. Offers will be released on a rolling basis beginning Dec. 15. Applications will be accepted from 1Ls and 2Ls. Students can apply here.

#### JANET D. STEIGER FELLOWSHIP PROGRAM

The Janet D. Steiger Fellowship Project provides law students with the opportunity to work in the consumer protection departments of state and territorial Offices of Attorneys General and other consumer protection agencies, as well as the National Association of Attorneys General and the Attorney General's Office of DC. Each selected fellow will receive a \$6,000 stipend. Applications will be reviewed after the deadline date of **Nov. 28**. #### JUSTICE IN AGING - COLIN ALEXANDER LAW FELLOWSHIP (REMOTE)

This is a full-time, remote, paid fellowship. Justice in Aging is a national organization that uses the power of law to fight senior poverty by securing access to affordable health care, economic security, and the courts for older adults with limited resources. They are seeking a rising 3L (current 2L) to work full-time with attorneys on multiple projects related to Medicare, Medicaid, and other health programs that impact older adults. The fellow will be provided a \$9,000 stipend. Applications accepted until **Nov. 14**, and reviewed on a rolling basis.

#### JUSTICE IN AGING - RACIAL JUSTICE FELLOWSHIP (REMOTE)

This is a full-time, remote, paid fellowship. Justice in Aging seeks a rising 3L (current 2L) to work full-time with attorneys on multiple projects that integrate Justice in Aging's core programs (health care, economic security, housing, and elder justice) and focus on racial justice. The fellow will be provided a \$9,000 stipend. Applications accepted until **Nov. 14**, and reviewed on a rolling basis.

#### JUST FUTURES LAW - SUMMER 2026 (REMOTE)

Just Futures Law is a movement organization that defends and builds the power of immigrants' rights and criminal justice activists, organizers, and community groups. Their mission is to prevent the criminalization, detention, and deportation of immigrants and people of color in the US. Just Futures Law seeks interns for Summer 2026, who will support the organization's programmatic work around the fast-developing field of technology-driven immigration enforcement. A stipend of up to \$6,125 is available for those students who do not receive outside funding. This position is open **until filled**.

#### SUMMER 2026 OPPORTUNITIES

#### NATIONAL HOUSING LAW PROJECT - SUMMER 2026 CLERKSHIPS

NHLP's mission is to advance housing justice for poor people and communities. NHLP is currently accepting applications from law students for summer 2026 clerkship positions. The clerkship is a full-time position that will last approximately 10 weeks. Clerks have the option of working remotely from anywhere. NHLP will offer supplemental funding to clerks so that each clerk will receive a total of \$7,500 for the summer, regardless of their ability to secure outside funding. Deadline to apply is **Dec. 15**. Applications reviewed on a rolling basis so early applications are encouraged.

#### 2026 HAYWOOD BURNS MEMORIAL FELLOWSHIPS

Burns fellowships are designed to encourage work in the National Lawyers Guild's tradition of "people's lawyering." The program helps students and legal workers apply their talents and skills to find creative ways to use the law to advance justice. Fellowships may be completed with NLG aligned organizations or law firms whose mission is in line with the Guild's commitment to prioritizing people and ecosystems over property interests. #### PALM BEACH COUNTY BAR ASSOC. - ADVANCING OPPORTUNITIES INTERNSHIP PROGRAM

The Palm Beach County Bar Association is seeking candidates for its Advancing Opportunities Internship Program. Applications can be found at the <u>bar's website</u>. Candidates must be 1L or 2L students who are interested in working in Palm Beach County. The program offers law students from traditionally underrepresented backgrounds the opportunity to gain meaningful, hands-on experience with local law firms, government agencies, and state and federal judges, while building professional connections throughout the Palm Beach County legal community. Deadline to apply is **Jan. 9**.

#### JUDICIAL INTERN OPPORTUNITY PROGRAM

JIOP is a summer internship open to all first- and second-year law students. JIOP supports the American Bar Association's goal of eliminating bias and advancing diversity in the legal profession. All students are welcome to apply. Selected students intern for six weeks or more during the summer with a participating state or federal judge. The program makes available a monetary award to each selected students. Students can also elect law school credit. Deadline to apply is **Jan. 9**. Locations include Miami and Ft. Lauderdale, FL.

#### **NACA 2026 CONSUMER LAW FELLOWSHIP**

The National Association of Consumer Advocates (NACA) are seeking motivated law students to apply to their Summer Consumer Law Fellowship Program. Interested students should arrange an internship position, contingent on funding, with a Legal Services of Public Interest Organization's consumer law unit or a private consumer law firm. #### SUMMER 2026 OPPORTUNITIES

#### FLORIDA ATTORNEY GENERAL'S INTERNSHIP PROGRAM - SUMMER INTERNSHIP

The Attorney General serves as the attorney for the State of Florida and as a member of the Florida cabinet. Interning for the Office of the Attorney General affords law students an opportunity to gain practical experience in a legal field and offers students a chance to perform meaningful work toward the completion of their degree. Students must be able to intern a minimum of 20 hours per week. Interested students are directed to complete and submit an application packet prior to **Feb**. **28**; however, students are encouraged to apply early as applications are accepted on a rolling basis. Law students who are not receiving academic credit for their work are eligible to receive legal pro bono credit towards the graduation requirement.

#### VETERANS LAW INSTITUTE- SUMMER 2026 (Rising 2L/Rising 3L)

Stetson Law's Veterans Law Institute Summer Fellowship offers rising 2Ls and 3Ls the opportunity to gain hands-on experience assisting veterans with disability benefits claims and discharge upgrades. Fellows will complete tasks such as conducting intake interviews, researching case law and medical journals, and drafting claims. This fellowship provides valuable exposure to veterans' legal advocacy while earning 250 legal pro bono hours upon successful completion. Applications open in spring 2026 on Symplicity.

#### PEGGY BROWNING FUND SUMMER FELLOWSHIPS

The Peggy Browning Fund Fellowship Program provides stipends to law students who dedicate their summer to the cause of workers' rights by working for labor unions, worker centers, labor-related not-for-profit organizations, union-side law firms, and other nonprofit organizations. It is a ten-week summer fellowship and is available to current 1L, 2L, &3E law students. PBF recruits interested students and works closely with their mentor (host) organizations to ensure that each fellow will experience unique and challenging work assignments. The 2<sup>nd</sup> round of the program, open to 1Ls, will open Nov. 6. Offers will be extended on a **rolling basis** starting on Dec. 6. The total stipend payment is \$7,000 (unless otherwise indicated). Learn more <u>here</u>.

#### INSTITUTE FOR JUSTICE - 2026 DAVE KENNEDY FELLOWSHIP

The Application for the 2026 Dave Kennedy Fellowship will open in November, with interviews being scheduled on a **rolling basis**, starting in December. IJ hires 21 fellows across all offices with a majority of students at their HQ in Arlington, VA. Law students contribute to active and future strategic litigation in both state and federal courts. During their summer, students work closely with IJ attorneys to develop litigation strategies and assist in cutting-edge civil rights litigation. This is a paid opportunity offering an \$8,000 stipend for the 10-week program.

#### FAIR AND JUST PROSECUTION - SUMMER FELLOWS PROGRAM

This program places 1L and 2L students in summer internship positions in prosecutor offices across the country. Participating students will have the opportunity to receive hands-on experience working on criminal cases and other assignments typical of internships in prosecutor's offices, while also undertaking a policy reform project on an issue of interest to that office. Participating offices may include but are not limited to: Washington, DC; Philadelphia, PA; Norfolk, VA; New York, NY; Dekalb County, GA; Boulder, CO; and more. Summer fellows receive a \$5,000 stipend. Applications from 2Ls considered on a **rolling basis**. Interested 1L students should ideally apply by **Jan. 23**.

#### POST-GRADUATE 2026 OPPORTUNITIES

#### GW LAW SCHOOL - LAW SCHOOL FELLOW

The George Washington University Law School is offering a 12-month fellowship designed to provide early-career professionals with hands-on experience and training in areas of law. GW Law School Fellow's assignments may include: assist attorneys with legal research, motions, advice memos, discovery, and trial; assist attorneys in gathering documents, answering interrogatories, or taking notes during a witness deposition; assist in drafting motions, advice memos, mediation statements, and case briefs. Applications accepted **until position filled**. This position is based in Washington, DC.

#### UNIVERSITY OF KANSAS - HUSCH BLACKWELL HIGHER EDUCATION LAW FELLOWSHIP

This fellowship is open to 3Ls and recent law school graduates and grants access into the legal life of the University of Kansas and the Office of the General Counsel. This is a salaried, 2-year position that provides an opportunity to work closely with General Counsel attorneys to gain the resources and mentorship necessary to prepare for a career in higher education. #### NATIONAL WILDLIFE FEDERATION - GREAT LAKES LEGAL FELLOW

They will participate in all aspects of litigation, from case development through appeal. Additionally, they will help to provide legal advice and technical assistance to clients. This position may be based anywhere within the U.S. Deadline to apply is **Jan. 2**.

#### NACA 2-YEAR CONSUMER LAW FELLOWSHIP

The National Association of Consumer Advocates (NACA) is offering two 2-year consumer law fellowships to upcoming law school graduates who are expected to sit for the July 2026 Bar exam. #### JUVENILE LAW CENTER - ZUBROW FELLOWSHIP

The Zubrow Fellowship in Children's Law is a 2-year fellowship in children's law. Zubrow fellows take on a variety of legal tasks and gain a comprehensive understanding of issues in the child welfare and justice systems. Fellows co-author groundbreaking reports, help pass legislative and executive reforms, and participate in major litigation. Applicants should have graduated or anticipate graduating law school or a dual degree program in law between 2024–2026. This position is based in Philadelphia, PA. Applications are due **Jan 16**.

#### POST-GRADUATE 2026 OPPORTUNITIES

#### **BREDHOFF & KAISER - GREENFIELD FELLOWS**

Bredhoff & Kaiser is now accepting applications for the 2026-2027 Greenfield Fellowship. Priority is given for applications received by **Dec. 1**. Bredhoff & Kaiser is one of the largest firms in the country focused on representing workers and labor organizations. Lawyers represent both international and local labor unions and related organizations, nonprofits, and individuals. Their work involves everything from RICO, antitrust, and constitutional cases to employee benefits, individual employment, tort and contract issues. This position is based in Washington, DC, and salaries are \$126,000/year.

#### WOMEN'S LAW & PUBLIC POLICY FELLOWSHIP PROGRAM

The Georgetown University Law Center is accepting applications for their WLPPFP Fellowship, which is a 12-month work experience, where Fellows from the US work on women's legal issues with a public interest organization. The application is due on **Nov. 26**. Fellows work to advance gender justice, learn about substantive women's rights issues, explore a multitude of career paths through which they can advocate for equality, and develop their legal and interpersonal skills through seminars, trainings, networking events, and other activities. Fellows will be required to reside in the Washington, DC area, even if their place is virtual or hybrid.

#### BARBARA A. RINGER COPYRIGHT HONORS PROGRAM

The Ringer Honors Program is a public service opportunity for law clerks and attorneys in the early stages of their careers who have a strong interest and demonstrated record of academic or practical success in copyright law. The Program accepts applications from individuals who are in their final year at a U.S.-accredited law school (receiving a JD or LLM) or who have practiced law for fewer than five years. The anticipated time frame in which the selected applicant would begin their fellowship would be September 2026. Deadline to apply is **Dec. 31**.

#### **VIRGINIA OAG - 2026 HONORS PROGRAM**

The Virginia Office of the Attorney General (OAG) ) is now accepting applications to its 2026 Honors Program. As an Honors Fellow, you'll begin your career immediately after taking the Virginia State Bar exam, contributing to significant legal matters that affect our state. Upon passing the bar, you'll be automatically promoted to Assistant Attorney General. You should have a J.D. from an accredited law school (or be expecting to graduate this year), intend to sit for the July 2026 Virginia State Bar exam, and possess strong research, writing, and analytical skills. Deadline to apply is **Jan. 2**.

#### **INNOCENCE & JUSTICE LOUISIANA - LAW FELLOW**
